1. The National Farmer's Commission invites sealed bids from eligible bidders for the procurement of **Motor Cycles(125 cc)**. Bidding is open to all eligible Bidders from all countries as defined in *Public Procurement Act 2063 and Regulation 2064 of the Government of Nepal*
2. Eligible Bidders may obtain further information and inspect the bidding documents at the office of National Farmer's Commission, telephone no. 977-1-4037046 or 4037056 and email address: nfcnepal2017@gmail.com
3. Bidding documents may be purchased from the above office of **National Farmer's Commission, Kalanki, Kathmandu** and **Ministry of Agriculture Development, Singha Darbar** by eligible Bidders on the submission of a written application, along with the copy of company/firm registration certificate, and upon payment of a non-refundable fee of **Rs.3,000.00 up to office hour of 4th January 2018**. If so requested, the Bidding Documents can also be sent by post/courier services upon payment of additional cost of NRs. **3,000.00**. However, the Employer will not be responsible for delay or non-delivery of the documents so sent.
4. Sealed Bids must be submitted to the above office of **National Farmer's Commission** on or before **12.00 Noon on 5th January, 2018**. Documents received after this deadline shall not be accepted.
5. Prebid meeting shall be held at National Farmer's Commission's Office, Kalanki at 3:00 PM on 26th December, 2017
6. Bids shall be opened in the presence of Bidders' representatives who choose to attend **5th January, 2018 at 15.00 hours** at the office of **National Farmer's Commission, Kalanki, Kathmandu**. Bids must be valid for a period of **90 days** counting from the day of bid opening and must be accompanied by bid security, amounting to a **minimum of Rs. 62,000 (Sixty Two Thousand)**., which shall be **valid for minimum 30 days** beyond the bid validity period (**5th May 2018**). If the bidder wants to deposit cash as bid security, the bid security amount may be deposited in the Everest Bank, Singha Durbar, in the Ko Le Ni Ka Dharauti Account No 135001 and should submit the Voucher along with the bid document.
7. If the last date of submission and opening falls on a government holiday then the next working day shall be considered the last day. In such a case the bid validity and bid security validity shall be recognized with effect from the original bid submission deadline.
8. The Purchaser reserves the right to accept or reject, wholly or partly any or all the bids without assigning reason, whatsoever.
9. Other mandatory information as per public procurement act 2063 and public procurement regulation 2064
