5. Prebid meeting shall be held at National Farmer's Commission's Office, Kalanki at 1:00 PM on 26th December, 2017
6. Electronic bids must be submitted through the website www.bolpatra.gov.np/egp on or before 12:00 hours on 5th January, 2018. Bids will be rejected after this deadline
7. Bids shall be opened in the presence of Bidders' representatives who choose to attend on **5th January, 2018 at 13.00 hours** at the office of ***National Farmer's Commission, Kalanki, Kathmandu***. Bids must be valid for a period of **90 days** counting from the day of bid opening and must be accompanied by bid security or scanned copy of the bid security in pdf format in case of ebid, amounting to a **minimum of Rs 1050000 (Ten Lakh Fifty Thousand)**, which shall be **valid for minimum of 30 days** beyond the bid validity period (**5th May 2018**). Bidders may deposit cash as bid security, in the Everest Bank, Singha Durbar, in the Ko Le Ni Ka Dharauti Account No 135001 and should submit the pdf copy of the Voucher along with the bid document.
8. If the last date of submission and opening falls on a government holiday then the next working day shall be considered the last day. In such a case the bid validity and bid security validity shall be recognized with effect from the original bid submission deadline.
